

FINNISH CHAMPIONSHIP FOR DRAGON AND 606 CLASSES SEPTEMBER 17 – 19, 2021 AT NJK, HELSINKI FINLAND

NOTICE OF RACE

The Championship will be organized by Nyländska Jaktklubben (NJK), Vaskilahdenkuja 9, 00200 Helsinki, in conjunction with the Finnish Dragon Association (FDA) and the Finnish 606 Association.

1. RULES.

The following rules will apply:

- 1.1. The Rules as defined in The Racing Rules of Sailing (RSS)
- 1.2. The General and Class specific Finnish Championships rules
- 1.2. Authority (Covid19) prescriptions
- 1.3. The Equipment Rules of Sailing
- 1.4. RRS Appendix S Standard Sailing Instructions

2. ELIGIBILITY AND ENTRY

- 3.1 The race is open to all boats of the Dragon and 606 classes that meet with the obligations of the Class Rules and their National Authority
- 3.2 Eligible boats may enter by completing the entry form online at http://www.manage2-sail.com/. Entry is not valid until the fee has been paid, see §4.

Entries close on Tuesday September 14. Late entries may be accepted at the organizing Authority's discretion.

- 3.3. 606 boats have a crew of 2 or 3 persons.
- 3.4. Crew changes are allowed only with the written permission of the Race Committee.

4. FEES

- 4.1. The Entry Fee is 130 € (Dragons) and 100€ (606). For late entries the additional fee is 30€. The Entry Fee includes launching, lifting and berthing for the event, and trailer storage.
- 4.2. The Entry Fee shall be paid through the entry system using credit card or bank transfer. In case of problems the fee should be paid to the bank account of NJK:

5. SCHEDULE

- 5.1. The Race Office is open as required and can be reached on the phone number 040-5404862 (Pata Andersson). Registration at the Race Office is not compulsory.
- 5.2. All boats are to be afloat before 10.00 on Friday September 17. Boats shall not be hauled out during the regatta, except with written permission of the Jury or RC.
- 5.3. Weighing In for Dragon class crews is open at 19:00 20:00 on Thursday September 16 and at 09:00 10:00 on Friday September 17.

5.4. Racing Schedule:

Friday September 17 First start, Dragon at 12.30, 3 races scheduled. First start, 606 class at 14:00. 2 races scheduled. Saturday September 18 First start at 11.00, 3 races scheduled Sunday September 19 First start at 11.00 2 races scheduled

On the last day of the regatta no warning signal will be made after 15.00

6. MEASUREMENTS

6.1. Each boat shall produce a valid measurement certificate. Boats and equipment, may be controlled, before and after the races and during the racing days, and the crew can be weighed

7. SAILING INSTRUCTIONS

Supplementary Sailing Instructions will be available on Manage2sail.com no later than September 15. Copies of the Sailing instructions may be posted at the Notice board in front of the Race Office.

8. VENUE

- 8.1 The course area will be area D, "Melkki". (The Helsinki Race Courses)
- 8.2. Race Office and Mooring will be at Koivusaari/Björkholmen.

9. THE COURSES

The course to be sailed will be of windward-leeward configuration.

10. PENALTY SYSTEM

10.1 Rules 44.1 and 44.2 are changed so that only one turn, including one tack and one gybe, is required. .

11. SCORING

- 11.1 The Low Point System of Appendix 'A' will apply.
- 11.2 Four (4) races are required to be completed to constitute a valid championship series for the Dragon class, two (2) races for the 606 class.
- 11.3 (a) When fewer than five races have been completed, a boat's series score will be the total of her race scores.
- (b) When five or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

12. PRIZES

The three first boats in each class will receive Finnish Championship medals. Other prizes will be distributed in accordance with the Finnish Sailing and Boating Association's recommendations.

13. DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See Rule Decision to Race. The organizing authority will not accept any liability for material damage, personal injury or death sustained in conjunction with, prior to, during, or after the regatta.

14. INSURANCE

The boat is required to hold adequate third part insurance, and it is the owner's or the owner's representative's sole and inescapable responsibility to ensure that the insurance is in place and is adequate.
